But in these unprecedented times, that event center has at times given way to new ways of business that is helping the New Britain Memorial-Donald D. Sagarino Funeral Home continue to serve the community while much of the community has been brought to a halt during the coronavirus pandemic.

Currently, the funeral home offers in-person arrangements and pre-planning consultations from the safety of one's own home, and also helps families with phone, email and web arrangements to plan for funerals. 
