They also provide dietary needs, nursing and physician services and medication management.

Memory care at Grandview is based on the abilities of each resident, focusing on strengths rather than weaknesses. Every resident in the program receives a personalized plan of care with an ongoing assessment of changing need and they have individually tailored activities scheduled for seven days a week.
