Both John and Claudia Barbieri said it is important for them to be active members of the community.

"It is important to give back to people who are less fortunate than us," John Barbieri said. "We get a lot of satisfaction from doing that; it's very rewarding."

Claudia Barbieri said she was raised by her father to share in these values.

"Community service and helping people who need help is important to us," she said.

For the past 38 years, John Barbieri has chaired or co-chaired CCARC's annual golf tournament fundraiser. CCARC is a local nonprofit organization that provides opportunities for independence and personal growth for people

with disabilities.

"We just completed the 50th annual golf tournament, which raised \$101,000 at that event," he said. "The tournament has probably raised well over \$1 million over the years."

Claudia Barbieri has served on the Board of Directors for the Prudence Crandall Center for 10 years, including 7 years as board president. The local nonprofit supports victims of domestic violence and provides emergency shelter for women and children who have been victimized. The organization also seeks to educate the community with the goal of reducing or eliminating domestic violence.

The coronavirus has resulted in Barbieri Law, LLC adjusting the way it provides service to keep both attorneys and clients safe.

"We no longer just let people walk in," John Barbieri said. "We are doing a lot of contract signing at the curbside or at our front stairs. Now that the courts are starting up again, we are doing a lot more with remote hearings."
